

Privacy policy ONLINEYOUNET

This privacy policy (hereinafter - "Policy") describes what information the Company (hereinafter - "ONLINEYOUNET", represented by Private Entrepreneur I. P. Nepochtova) collects about you and why, how the Company uses the collected information and in what cases it is disclosed.

1. General provisions

- 1.1. By using our Site, you accept this Policy and consent to the collection, storage, use, and disclosure of your personal data.
- 1.2. All terms used in this Policy have the same meaning as in the terms of use of the Site. This Policy is an appendix to the Terms of Use.

2. What information we collect?

- 2.1. First of all, you can visit the publicly accessible sections of the Site anonymously without revealing your name or any other information.
- 2.2. To be notified of telecommunications offers from the Site, you must leave an email or sign in with your Gmail, Facebook, Messenger, Viber or Telegram account.
- 2.3. When you log in with your social media accounts, the Company has access to all visible information contained in your account in accordance with its privacy settings. However, the Company only collects and uses information such as:
 - first and last name;
 - email address;
- 2.4. In addition to the above information, the Company collects some data automatically, namely information about the devices with which you use the Site, the IP addresses of your devices, the browser and operating system version used, the time and date of access to the Site, the URLs from which you were referred, your general geographic location. This facilitates the operation and use of the Site.

3. How we use your information?

- 3.1. Your information is used by the Company to:
 - to provide the services offered on the Site;
 - facilitate the use of the Site and improve the quality of the Site;
 - informing about important news, services and promotional offers of the Site.
- 3.2. The Company may from time to time send e-mails to Users about Company news or other announcements about its activities. Users may unsubscribe from such emails by clicking the unsubscribe link at the bottom of the email.

4. Do we disclose your information?

- 4.1. The Company does not transfer or disclose Users' personal data to third parties, except when:
 - The Company has obtained the User's consent for such disclosure;
 - such actions are obligatory under the current legislation of Ukraine;
 - there are reasonable grounds to believe that the disclosure of such information is necessary to comply with the applicable laws of Ukraine, the requirements of the legal process or a legitimate request of state authorities.

5. Protection of personal data

- 5.1. User information is stored on our secure servers. Regardless of server location, the Company takes all necessary measures to protect Users' personal data from unauthorized access, modification, disclosure or destruction.
- 5.2. At the same time, the Company draws attention to the fact that none of the existing methods of data transfer can be absolutely secure. Therefore, the Company, in spite of all measures taken to ensure security, cannot guarantee the full safety of data.

6. Company Responsibility

- 6.1. The Company is responsible for all actions and omissions with respect to personal data of Users within the scope of the applicable law.
- 6.2. The Company is not responsible for any actions of Users of the Site and third parties with personal data of Users, regardless of whether these data are obtained through the Site or otherwise.

7. Links to external sites

- 7.1. The Site may contain links to third-party sites. The Company is not responsible for the content and activities of such sites, nor is it responsible for ensuring your privacy.

8. Changes to policy

- 8.1. The Company may update, edit and amend this Policy without further notice. Such changes shall be published on the Website and shall become effective immediately upon publication, unless otherwise specified in the changes themselves.
